1.1 Research Grants - Standard Route

- Research Grants awards are intended to enable individual researchers to collaborate with, and bring benefits to, other individuals and organisations through the conduct of research.
- The standard route provides grants for projects with a full economic cost (fEC) between £20,000 and £1,000,000 for a varying duration up to a limit of 60 months.
- DEADLINES: Applications may be submitted under the Scheme at any time there are no fixed closing dates.

1.2 Research Grants –early career route

- supports well-defined research projects enabling individual researchers to collaborate with, and bring benefits to, other individuals and organisations through the conduct of research within the AHRC's remit.

- Applications may be submitted for proposals with a full economic cost between £20,000 and £200,000 and for a duration of up to 60 months.
- DEADLINES: Applications may be submitted under the Scheme at any time there are no fixed closing dates.

 - A minimum funding level of £1·2m (100% FEC) will be introduced (the maximum funding level of £3·7m remains unchanged).
 - An outline proposal must first be submitted for consideration and only successful outlines may proceed to the full proposal stage.
 - o Outlines will be assessed against the criteria 'potential excellence' and 'fit to scheme'.
- There will be one outline and one full proposal closing date per year.
- DEADLINES: Dates for 2012 are as follows:
 - Outline Proposal Closing Date: 1 March 2012
 - o Full Proposal Closing date: 15 November 2012 (tbc)

3.2 Standard Grants

- EPSRC's remit covers engineering and the physical sciences: research in the areas of chemistry, engineering, information and communications technologies, materials, mathematical sciences and physics.
- DEADLINES: There are no closing dates so applications can be made at any time.

5 BRITISH ACADEMY

- All applications should demonstrate that Academy funds are sought for a clearly defined, discrete piece of research, which will have an identifiable outcome on completion of the Academy-funded component of the research.
- DEADLINES: The closing date for applications for the current round has passed. Award decisions will be confirmed by March 2012, to start from April 2012 onwards. A further round of competition will be announced in the course of 2012.

5.2 International Partnership and Mobility Scheme

- DEADLINES: Outline Applications can be submitted at any time. The deadlines for full applications (by invitation only) are on the 1 September, 1 December and the 21 March.

- The scheme covers all areas of the life and physical sciences, including engineering, but excluding clinical medicine.
- DEADLINES: The 2012 Research Grant round will open in the latter half of 2012.

7.2 JSPS Postdoctoral Fellowship

- The JSPS Postdoctoral Fellowship scheme is funded by the Japan Society for the Promotion of Science and is for scientists in the UK who are at an early stage of their career and wish to conduct research in Japan. The research undertaken must be on a subject within the natural sciences, including: physics, chemistry, mathematics, computer science, engineering science, agricultural and medical research (non-clinical only).
- The applicant must have a PhD, or be likely to have one by the start of the funding. They must also be within six years of the award of their PhD and have a research proposal agreed with a Japanese scientist.
- JSPS will provide funding for visits of between 12 months minimum and up to 24 months maximum.
- DEADLINES: Applications are made using the Royal Society's online form. The next closing date is planned for the end of February 2012.

7.3 Newton international fellowship

- The Newton international fellowship scheme is run jointly by the British Academy and the Royal Society. It is for non-UK scientists who are at an early stage of their career and wish to conduct research in the UK for up to 2 years. The scheme covers the broad range of the natural and social sciences and the humanities.
- The applicant must have a PhD, or be likely to have a PhD by the time the funding starts, be at an early stage of their career (no more than 1 or 2 post-doc positions), be working outside the UK and not hold UK citizenship.
- Newton Fellowships last for two years. Funding consists of £24,000 per annum for subsistence costs, and up to £8,000 per annum for research expenses, as well as a one-off payment of up to £2,000 for relocation expenses.
- DEADLINES: The next call is expected in January 2012.

7.4 Industry fellowship

 The Industry fellowship scheme is for academic scientists who want to work on a collaborative project with industry and for scientists in industry who want to work on a collaborative project with an academic organisation. The scheme covers all areas of the life and physical sciences, including engineering, but excluding clinical medicine.

- The scheme provides a basic salary for the researcher and a contribution towards research costs.
- The applicant must have a PhD or be of equivalent standing in their profession and hold a permanent post in a university, not-for-profit research organisation or industry in the UK.
- DEADLINES: The deadline for applications is anticipated to be early Summer 2012.

7.5 International exchanges scheme

- The International exchanges scheme is for scientists in the UK who want to collaborate with scientists overseas through either a one-off visit or bilateral travel. The scheme covers all areas of the life and physical sciences, including engineering, but excluding clinical medicine.
- Both the UK applicant and overseas applicant must have a PhD, or be likely to have a PhD by the time the
 funding starts and hold a fixed or permanent contract at an eligible organisation for the duration of the project
 (ineligible organisations include industrial, private and commercial organisations, university spin-out companies,
 government bodies and research institutes and research councils).
